## Qanuriliyuqaqqata Ilitturipkaidjutikhat

Kipluiyunut uqpigarnik nappaaktuniklu hanianit nappaqutanit alruyaqtuutiqaqtunit nallaumayunit, havakti kipluipluni nappaaktumik ulruhimayumik alruyaqaqtutimut pauvatuutikhanut quakhalarnaqtunut alruyanut. Pauvatuutit alruyaq kikturakhimayuq tunngayuqlu nunamut, alruyanit quakhalarnaqtuq allamut havaktimut tuttuq hanianitumut havagvianut. Tamna havakti uttiqpiaktuq alruyanit quakhalarami aktuqtaugami alruyamit aulayumut alruyaqtuutitut.

## Qayangnaqtunut Naittumik –

### Havaktunut Haniani Nappaqutat Alruyaqaqtut:

**Havaktut haniani alruyat pauvaqaqtunit alruyanit qayangnaqpiaktuq tuqqunakhunillu.**

Havaktit havakangamik havaakhanik haninaniitunik nappaqutat alruyaqaqtutnilihaudjauvaktukhauyut ihuaqtunik kangiqhidjutikhainik qanuqtut qayangnaitkutikhainiklu.

Naunaiyaqtauyukhat Qayarnirit Naunaiqtauhimayut (naunaiqtauhimaitut quarhalaarnaqtut) unalu Naunaiyaqtauyukhat Qayarnirit (naunaiqtauhimayut quarhalaarnaqtut) piyariaqaqtut qayagiyariaqaqtutlu.

## Qayangnaitumik Havakvikhat Atuqtauyukhat:

1. Havaktit ingilrutitlu havaktukhaungitut haniani Qayarnirit Naunaiqtauhimayut (unngahikniani 3 miitamik nivingayunit alruyanit ) ilitturipkakhimaitumik pauvaqarviit nunamingni: Northwest Territories Power Corporation-(NCPK-ktut); Northland Utilities-ktut – Yellowknife; uvaluunniit Northland Utilities – Hay River-mi.
2. Ayuikhaqhimaitut havaktit itiqtukhaungitut hamunga Qayarnirit Naunaiqtauhimayut.
3. Havaktut haniani pauvatutit alruyanit piyariaqaqtut naunaikhihimayumik ayuikhaqhimayumiklu qungiaktikhamik/naunaiyaiyikhamiklu piyangini havaktit ingilrutitlu ihuaqtumik qayangnaitumiklu unngahiktilakhainik pauvaqaqtunit alruyanit. Qungiaktikhaq kangikhinaqtumik uqautikhaqaqtukhauyuq havaktinut nallautikkut ququrutikkutluunniit.
4. Kipluiyut haniani pauvatutit alruyanit havakpaktukhauyut ubluumanginarmi ikarniini.
5. Hivuanit havalirumik uvaluunniit allanik huliakhanik haniani pauvaqaqtut alruyanit, uqaqvigiyakhat pauvaqarviit hanaqiyamingnik qayangnaitunik unngahiktilakhaanik qayangnaqtunit qayangnaitkutikhamik.



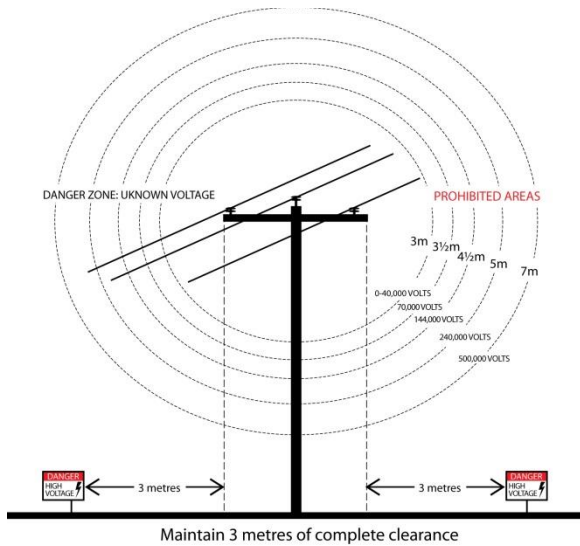
