WSCC-kut havaanga atuliqtitaugiami havakviit aaniaqtailiniq aaniqtailiniqlu tunitillugu pipkaidjutingittumik akiliuhiarutikhat atan'nguyamut munariniqlu aaniqtunut havaktut. Munariyavut pivalianivut taututtiaqhugit tuhaqhitautilu ukiumut

Taamna 2025-mi Kiinauyaliriyiimut Ihumaliurut hanahimmaaqpaktuq hivulliinqit ukiumit ikayuqhugit 2023-2027-mi Ihumaliurhimayut Ihumaliurunut, *Apqutit Mikhaanut Hivuranailrut*, ilittuqhivitaghunilu nutaanik Havaaghanik ihumagiplugit iniqtaghavut ihuaqnighakuut Inirumayaptingnik Ihumagilluaqtaptingniklu. Tunngatilik ilitpalianginnarniqmut atuqpalianitlu pivaliani hilataanit avatainit, tamna Ihumaliurut hivuliqtai qau tamaat aulatyutivut pipkaqtatigutlu havarittiaqni atuqpiarahuaqtavut.

Tamna 2025 Kiinauyaliriyiimut Ihumaliurut piliurhimayug talvangaanit ilangani 91(1) uumannga Nunavut Kavamanga *Kiinauyaliriniqmut Titiqiqinirmut Maligaaq, unalu Nunatsiap Kavamanga Ihumaliurniqmut Kiuttaarniqmullu Tunngavinga ihariagiayuyug titiraqhimannngani 21 uumani Kiinauyaliriniqmut Titiqiqinirmut Maligaaq.*

Tapkuat Havaktut Qayagitjuttikhainnik uvalu Ikayukhiakuttikhianit Katimayiit (WSSC) ilagipyaktat kavamatkut havaktit havalgit aulattangi tapkuat *Havaktit Utiqviuni Maligaqyuat*, *Hivuranailrumitnit Maligaqyuat*, *Qagaktautit Atuqni Maligaqyuat* tamnalu *Uyarakhiuqvut Aaniaqtailiniq Hivuranailrumitnilu Maligaqyuat* tahamani Nunatsiaq tamnalu Nunavut.

Tapkuat WSSC-kut piqaqtitai kivgaqtutit tapkununga mikhaanut 40,000 havaktit tapkuatlu 4,000 havaktituyit humiliqak malrukni nunatagaayuk. WSSC-kut havakti havariyai avataani 3,000 utiqviuyut ukiuq tamaat havarinilu avataani 1,000 qauihaqnit ukiuq tamaat atuqpiariangi hivuranailrumitni ukiuqtaqtumi havakviit. Una WSSC arlingnaqhutik iluani Kanata havaktinut ikayuutikhautauullarningit timiuyunut iluani nunaryuangani ikayulluaqhugit havaktinut tamainnut amigaitqiyauvlutik nunalimaanmi nunallaamiluuniit.






