## Workers' Compensation Act, Northwest Territories

## 22. (1) Compensation is payable in respect of a worker 22. Extension of time (2) The Commission may, on application by the Extension of time (2) The Commission may, on application by the employer, extend the six month limit referred to in employer, extend the six-month limit referred to in paragraph (1) (c), before or after it expires, for such paragraph (1) (c), before or after it expires, for such longer period as the Commission considers reasonable. longer period as the Commission considers reasonable. Forfeit rights (7) A person who contravenes subsection (5) Forfeit rights (7) A person who contravenes subsection (5) (a) is deemed to have forfeited all rights to and repay and repay (a) is deemed to have forfeited all rights to compensation compensation under this Act; and compensation compensation under this Act; and (b) shall repay any compensation paid to, or on (b) shall repay any compensation paid to, or on behalf of, that person by the Commission. behalf of, that person by the Commission.
