## Senior OHS Inspector, Iqaluit, N 21/58 NU

The Workers' Safety and Compensation Commission's (WSCC) vision is to eliminate workplace diseases and injuries. Our mission is to promote workplace health and safety while providing no fault insurance to employers and care for injured workers. Our values are respect, engagement, integrity, openness, cultural safety, excellence and stewardship in the workplace.

As a part of the Prevention Services team, this position reports to the Deputy Chief Inspector and is based in Iqaluit. The Senior OHS Inspector directly contributes to the WSCC's vision, mission and values by promoting education, awareness, compliance and enforcement of worker Health and Safety in the NT and NU. This position is a legislated requirement, and has specific legislative duties and authorities under the *Northwest Territories (NT) and Nunavut (NU) Safety Acts, and* the associated *Regulations*.

The Sr. Inspector provides services to employers, workers, and the public and is appointed under the legislation as Safety Officers. In compliance with the Northwest Territories (NT) and Nunavut (NU) *Safety Acts,* and the associated Regulations (*Regs*), and fosters the vision, mission and values of the Workers' Safety and Compensation Commission. The *Acts* and *Regulations* give the Inspector the legislative authority to enter worksites to assess compliance with the *Acts & Regs,* to conduct inspections and investigate dangerous occurrences, serious injuries or fatalities, work refusals and employee claims of discrimination.

We are looking for a safety professional with diplomacy, negotiation skills and knowledge of the *Acts & Regulations*, industry standards and other related acts, codes and regulations as well as investigative principles and procedures. The Senior OHS Inspector is accountable to enforce the *Acts* and other legislation pertaining to worker safety under the direction of the Deputy and Chief OHS Inspector. Frequent duty travel is required in this position.

This position requires a related two-year post-secondary diploma and the Canadian Registered Safety Professional (CRSP) designation, combined with a minimum of five (5) years of progressive experience working in an industrial safety field. Experience in Dangerous Occurrence investigations and Workplace Accidents Causing Bodily Harm investigation is also required. The incumbent is also required to hold a valid class 5 Driver's License. We consider equivalent combinations of education and experience on a case-by-case basis.

The salary ranges from \$53.00 to \$63.31 hourly (approx. \$103,350 to \$123,455 annually), plus a Northern Allowance of \$24,054 annually.

A satisfactory criminal records check is required for this position.
