The Youth Safety Program Coordinator position can operate out of WSCC's Iqaluit or Yellowknife office. The position reports directly to the Manager, Program Development and Stakeholder Engagement, who is based in Yellowknife, within the Legal and Compliance Division at the WSCC. Program Development and Stakeholder Engagement unit is responsible for the development, implementation, and evaluation of WSCC's programs, and additionally is responsible for WSCC's stakeholder engagement activities.

The Youth Safety Program Coordinator is responsible for promoting, coordinating, and maintaining participant records for Workers' Safety and Compensation Commission's (WSCC) Youth Safety Leadership Program. The incumbent is the first point of contact for program participants, and will provide a support role to participants as they work their way through the program requirements. The Youth Safety Program Coordinator works with the Program Development Officer responsible for the Young Workers' Program to identify program requirements and areas for further development to the Young Workers' Program and the newly established Youth Safety Leadership Program.

They will work closely with WSCC's Prevention Services unit, other WSCC divisions as required, as well as external stakeholders. The Youth Safety Program Coordinator will be asked to be pro-active in developing the WSCCs contact lists for stakeholders interested in youth focused job readiness and safety programs, as well as businesses that regularly employ young workers.
