Our values are respect, engagement, integrity, openness, cultural safety, excellence and stewardship in the workplace.

The Vice President, WSCC NU (VP) provides executive direction and leadership to Nunavut Operations and has shared accountability for the strategic direction of all workplace injuries and illness prevention, care for workers, return to work programs and employer registration activities provided by the WSCC for the NWT and NU. Working with partners and stakeholders to achieve the strategic priorities of the Workers' Compensation Commission's Strategic Plan and the objectives of the Corporate Plan the Vice President champions workplace safety and care for workers. In addition, the VP shares accountability for the education, administration and enforcement of the NWT and Nunavut *Safety Acts*, the *Mine Health and Safety Acts*, and the *Explosives Use Acts*, and other legislation and programs pertaining to worker health and safety, and employer registration activities.

This position is located in Iqaluit and reports directly to the President and CEO. As a member of the Senior Management Team, the VP, WSCC NU participates in the executive management of the division in support of the WSCC's Vision and Mission. The VP is responsible for ensuring internal and external collaborative networks are established and maintained.

The ideal candidate will have extensive experience and the ability to lead multi-disciplinary team demonstrated senior level strategic planning and management skills, and a strong understanding of the of the economic and political climate of the Territories that impact the WSCC's ability to deliver its services.

This position requires a degree in a related discipline, and at least 7 years of experience in a related field are required, including 5 years of recent senior leadership experience. Related education includes, but is not limited to, health, social sciences, public administration, business administration, occupational health and safety, etc. Equivalent combinations of education and experience will be considered on a case by case basis.

Salary ranges from \$68.94 to \$98.48 hourly (approx. \$134,433 to \$192,036 annually), plus an annual Northern Allowance of \$20, 591.
